

New Structure WG-4IR

- Complexity and broad variety of discussion topics
 - →need for a Steering Committee on 4IR (SC WG-4IR) driving topic related Sub-Working Groups (SWG-4IR)
- The SC WG-4IR / SWG-4IR will elect a Chair and Vice Chair from amongst its membership once every two years
- The chairperson of each SWG-4IR will be de facto member of the SC WG-4IR
- The SC WG-4IR or SWG-4IR may invite guests or experts to its meetings to provide input and advice when required

- Define areas of synergy between the sub-working groups
- Define area of synergy / communication with other initiatives at the AHK
 - Education & Training Advisory Committee
 - Competence Centres (e.g. Mining & Raw Materials)
- Communication to the CEO & Senior Council AHK / EU & Bilateral Chambers
